## HAZARD ALERT: Occupational Noise Exposure

Exposure to high levels of noise can cause permanent hearing loss. Neither surgery nor a hearing aid can help correct this type of hearing loss. Short term exposure to loud noise can also cause a temporary change in hearing (your ears may feel stuffed up) or a ringing in your ears (tinnitus). These short-term problems may go

away within a few minutes or hours after leaving the noise. However, repeated exposures to loud noise can lead to permanent tinnitus and/or hearing loss.

#### How loud is too loud?

#### **Rules of thumb:**

- You have to shout to communicate at a distance of three feet /an arm's length away from your coworker.
- You notice that speech and other sounds are muffled for several hours after your work shift.
- You notice that sounds develop ringing in your ears after your work shift.

#### **Occupational Safety and Health Administration (OSHA) Regulation**

OSHA sets legal limits on noise exposure in the workplace. These limits are based on worker's time weighted average over an 8-hour day.

Permissible Exposure Limit (PEL) is 90 dB, it is the level where controls need to be put in place to reduce employee exposure.

Action Level (AL) is 85 dB, it is the level where employees are placed into a Hearing Conservation Program and noise monitoring is conducted and controls are explored.

#### **Noise Levels Examples**

Pneumatic drill = 130 dB	Air handler = 91 dB
Radial arm saw = 120 dB	Mower = 90 dB
Generator = 103 dB	Chiller = 87 dB
Strobic fan = 94 dB	Office space = 50 dB



- Failure to provide a reason for decline. failure to respond, and failure to showup for an assigned training class will result in a no-show charge of \$75 to your shop for each occurrence.

Calendar invites for training classes must be accepted or declined within 3 days of receiving them! This allows OHS to adequately prepare and plan for our training.

# WHERE is **Occupational Programs?**

The FM-Occupational Programs department houses three important FM programs:

- The Apprenticeship Program, • headed up by Brian Shifflett and assisted by Cynthea Wagner. This team is located on the second floor of Lacy near the Lock Shop.
- **Occupational Training** (formerly Training & Development). This group is made up of Julie Thomas, Elizabeth Campbell, and Sarah Ditulli. This team helps facilitate the growth and professional development of FM employees. They are located on the second floor of Lacy Hall adjacent to the Apprenticeship Team.
- **Occupational Health & Safety** oversees safety training for FM employees, provides ergonomic assessments, air and noise sampling as requested, respiratory fit testing, and conducts incident reviews when an employee is injured or faces a workplace hazard. This team is located in the lower level of Skipwith Hall and is made up of Trey Dean, Bobby Glenn, Narges Sinaki, and Bonnie Hockins.

Supporting these teams are Linda Resco, Samantha Whalen, and Liz Burnett, who coordinate trainings, create documents, and manage recordkeeping, among the many other tasks needed to ensure the department operates smoothly.

will focus on the BEST Program: The Department of Labor and Industry's Virginia Occupational Safety and Health (VOSH) program and the Associated General Contractors of Virginia (AGCVA) have established a strategic partnership entitled "Virginia BEST" to improve best practices, compliance efforts and accident prevention on construction worksites through recognizing the outstanding efforts of exemplary construction employers.

Making, Develop Self & Others, and encourage Diversity and Respectful Workplace conduct. Exercises have been designed to take approximately 10 minutes to complete with a group. One new power tool will be sent every month to further develop our supervisors.

Basics of AiM: A new course covering the basics of using Aim will be available twice a month beginning February 7.

**ESL:** FM's partnership with the Center for American English Language and Culture (CAELC) at the University of Virginia continues to grow stronger. Not only did we just complete our first year of participation in ESL Conversational Coaching Sessions, members of FM also teamed up with CAELC team members to offer additional Workday training and support to English Language Learners. The one-on-one ESL coaching sessions are open to any English Language Learners who are currently employed with Facilities Management – temp or full-time employees – and focus on general conversation skills as well as specific tasks or communications shared by supervisors with CAELC. The ESL Conversational Coaching sessions resume February 12, 2019.

**Progressive Discipline Overview:** In partnership with UVA HR Employee Relations, Occupational Training will offer Supervisors/Managers this workshop to builds skills in the management and application of employee discipline - while strengthening the organization through the strategic relevance of existing policy.

Written Notice Writing Workshop: In partnership with UVA HR Employee Relations, Occupational Training will offer Supervisors/Managers this workshop that goes through the process of data collection, analysis and policy interpretations in an upbeat and stress-free environment

**1st year Apprentice Written Communication Coaching:** In Partnership with the Curry School of Education, 1st year apprentices will receive work related writing skills to further advance their communication skills. This training is schedule to begin the first week of February.

# APPRENTICESHIP PROGRAM UPDATE

The University of Virginia Facilities Management's awardwinning Apprenticeship Program is excited to announce that it will be accepting applications for the program beginning February 1, 2019. Apprentices at UVA FM spend four years learning a skilled trade through a combination of on-the-job training, technical education, and classroom instruction. On-the-job training is conducted with licensed journeymen, mentors, and supervisors who ensure the highest-quality training in state-of-the-art University and Health System facilities.



Applicants must be high school graduates or hold an equivalent General Educational Development (GED) certificate. Additionally, applicants must be able to meet the physical requirements for their prospective trades. All UVA FM apprentices are full-time University employees with salary and benefits. The UVA FM Apprenticeship Program is recruiting for HVAC, electrical, plumbing, and sheet metal trades apprentices for 2019. Previous experience in the trades are not required. Applications will be accepted online at http://jobs.virginia.edu.

Prospective applicants can meet current apprentices, graduates of the program, and members of the UVA Facilities Management team at the Apprenticeship Job Fair on Wednesday, March 6, 2019 from 9-11 a.m., held at UVA's Alumni Hall, 211 Emmet Street South in Charlottesville. This is an informational job fair only, with several local businesses participating. Interviews will not be conducted on this day.

Established in 1982, the Apprenticeship program offers highly-motivated applicants an opportunity to learn a skilled trade through a combination of on-the-job training, technical education, and classroom instruction in a four-year program. This program was the first of its kind to be established by a state agency in Virginia and has served as a model for other programs. In addition to the success and longevity of the program, Facilities Management is proud that a majority of apprenticeship graduates choose to make a career at the University.

# **RECAP: Quarterly Meeting of the OHS Committee Chairs**

The Occupational Health and Safety Committee Chairs met in January to review accomplishments of the nine OHS Committees from across FM. This group, chaired by Benji Boatwright (Project Services) and Zach Carter (HSPP), reviewed the Safety Poster schedule, committed to sending an OHS committee representative to each FM Employee Council meeting, reviewed and discussed FM incident data. Each committee chair reviewed their committee's goals and achievements, including the following:

- **Project Services'** committee moved to update the scaffold policy to include that netting should be ordered/ provided for all scaffold requests to ensure that it is always set up and available.
- Health System Physical Plant (HSPP) has been focusing on updating buildings that have conditions that were been grandfathered in but are not up to code regarding to ladders, steps, etc.
- **Custodial Services** has begun working on developing their safety poster for 2019, is discussing potential for developing equipment-specific trainings, and is working with leadership to identify a list of restrictedduty job functions and tasks that can be done based on which restrictions are placed on an injured and/or recovering employee.
- Landscaping & Recycling is Improving focus on day-to-day operations, utilization of safety belts, refraining from cell phone use while operating vehicles, and getting their employees ready for the upcoming spring.
- **Special Trades** is encouraging employees to nominate Safety Stars and Safety Champions as this is a great tool to recognize employees for safe work practices
- Zone Maintenance is working on addressing commitment and attendance within the committee to encourage member involvement and engagement
- Facilitates Planning & Construction (FP&C) has recently had several new members join
- Energy & Utilities (E&U) is focusing on engineering controls review at the Heat Plant regarding fly ash to decrease employee exposure and risk to eye injuries.

Other highlights included the recognition of last quarter's Safety Champions and outgoing committee chairs. FM CFO Don Sundgren extended an invitation to Benji and Zach to attend an upcoming Directors Meeting and speak towards the OHS committee process and commitments regarding safety.

Personal protective equipment, or PPE, is designed to protect workers from serious workplace injuries or illnesses resulting from contact with chemical, radiological, physical, electrical, mechanical, or other workplace hazards. Besides face shields, safety glasses, hard hats, and safety shoes, protective equipment includes a variety of devices and garments such as goggles,coveralls, gloves, vests, earplugs, and respirators.
